Our audits check businesses for both risk and compliance. Areas reviewed include finance and operations

Audit programmes are agreed in advance and can cover any area of a business including;

- Full hotel audits reviewing all areas including Finance, Food and Beverage, Front of House, Housekeeping and Human Resources
- Cash handling & banking audits reviewing safes, cash counting areas, floats, end of shift documentation plus till to bank cash and credit card checks
- Food and Beverage operations audits including stock control and purchasing
- Specific finance audits, for example, credit control, purchasing and payroll

Reporting formats are agreed in advance and reports are discussed at the end of each audit.

# Test Purchasing ystery Guests

We co-ordinate **test purchase** visits to check cash handling accuracy in premises where cash accounts for a lot of the revenue, for example hotel bars and public houses. Integrity tests on employees are also conducted. A full report for checking against till systems is issued within two working days of any visit.

**Mystery guest** visits check employee and premises compliance with company and industry standards and relevant legislation.

Check lists are agreed in advance.
